## Notes for Applicants

1. This application form sets out the standard information which is required for Additional Authorisations for an Amateur Station Licence.

In certain cases, the Commission for Communications Regulation may seek further information or clarification from the applicant.

2. To submit a complete application, it is necessary:
  - to complete all sections of the Application Form and
  - to submit the full licence fee with the application

An application cannot be processed until ComReg has received a complete application.

3. All Additional Authorisations for Amateur Station Licences shall incur a fee of €30.
4. Additional Authorisations are only granted for a maximum of 12 months duration and expire thereafter. If the amateur wishes to continue to use such authorisations, a new application must be submitted to ComReg;
5. Prior to completing an application, applicants are advised to read document ComReg09/45 Amateur Station Licence Guidelines.
