Consumer Engagement


ComReg Consumer Line deals with consumers' queries and complaints via phone, email, online form, webchat and SMS service. In addition to a wide range of information for consumers ComReg offers a value comparison tool www.comreg.ie/compare that enables consumers to make informed choices when deciding to purchase a new service, switch service providers or change their package with the same service provider. This new tool offers increased functionality to consumers including the facility to compare communications service providers' market offerings by average monthly cost, total cost including handset costs, allowances and speed based on the information you enter. There are many additional features including the ability to select a preferred handset type when comparing available packages and to upload your bill to input your usage, download an application on your Android phone that calculates your usage, or choose predetermined usage levels for ease of use.

ComReg also offers an online facility to check the customer care details and other details for all premium rate services called Service Checker. Consumers can input the name or the number of the service that has been charged for and the details are returned with details of the customer service helpline number and email. 
