4. An application cannot be processed until ComReg has received a complete application, this may include any further information or clarification which ComReg may request as part of the application.
5. If there is insufficient space on the application form, the applicant may append additional material in support of the application for a wireless trial licence.
6. The fee for a wireless trial licence is €500 for 12 months (maximum duration), scaled per month down to a minimum fee of €100. The table below shows the range of fees:
