# 1 Overview

1. On 8 June 2012, the Commission for Communications Regulation (ComReg) held a workshop on its multi-band spectrum award process.
2. ComReg's intention to hold this workshop was identified in its Information Memorandum (Document 12/52) and also announced by way of information notice issued by ComReg on 29 May 2012 (Document 12/54).
3. In the latter document, ComReg indicated that the presentation materials and any substantive clarifications provided on the day of the workshop would be made available on its website.
4. ComReg has today published the presentation materials in Document 12/61A.

## 2 Modifications to Presentation Slides

5. A small number of modifications to the presentation slides used on the day have been made, being:

- on page 27 of the DotEcon “Key Features of the Award Process” presentation, “two constraints” now reads “three constraints”;
- on page 30 of the DotEcon “Technical Features of the Award Process” presentation, text towards the bottom left of the slide now reads “subsequent eligibility reductions” rather than “first eligibility reduction”; and
- on page 51 of the DotEcon “Technical Features of the Award Process” presentation, the entry relating to “Package 3” under the column heading “Final Price Cap” now correctly states “HB(4) + €66m”.

## 3 Clarifications

6. At the workshop, ComReg received two questions and stated that it would provide its response to same subsequent to the workshop.
7. Notwithstanding being raised at the workshop, ComReg is treating these questions as part of the formal Q&A process and will provide its provisional answer in due course because these questions relate to the award process generally, rather than to any particular presentation and, as such, ComReg's responses should be appropriately notified to all interested parties by the established procedure.
