1. Introduction

This information notice considers interim interconnection rates applicable for the periods between 1 October 2001 to 31 March 2002 and 1 April 2002 to 31 March 2003.

Interconnection rates for the period from 1 October 2001 to 31 March 2002 were set and announced during July 2001 on an interim basis for this period. Eircom has provided the ODTR with a revised interim RIO submission for this period. The Director of Telecommunications Regulation ("the Director") has undertaken a preliminary review of these rates and is proposing that these rates be set as the second interim rates for the period. Appendix 1 sets out these interim interconnect rates which will apply for the period from 1 October 2001 to 31 March 2002.

In their submission, *eircom* also proposed to set new interim rates for the 12 month period from 1 April 2002 to 31 March 2003. The Director has undertaken a preliminary review of these rates and is proposing that these rates be set as the new interim rates for the period. Appendix 2 sets out these interim interconnect rates which will apply for the 12 month period from 1 April 2002 to 31 March 2003.

The Director considers that the above rate changes be effected immediately and be applied retrospectively and settlement of arrears arising from the movement in RIO rates should be settled within 45 days.

While the ODTR has undertaken a preliminary review of these submissions provided by eircom, additional work and a more extensive review of these interim submissions will be undertaken in the coming month. The Director considers that the revised RIO rates will provide an immediate benefit to the market.
