#### 1. Introduction

This information Notice sets out Order Handling Charges for the following services.

- Carrier Pre-Selection (CPS).
- Wholesale Line Rental (WLR)
- Payphone Access Charges (PAC).
- Data Management Amendment.

Order handling charges are costs which an operator charges for the setting up a new customer. For example, CPS is the facility offered to customers which allows them to opt for certain defined classes of call to be carried by an operator selected in advance without having to dial a routing prefix or follow any other different procedure to invoke such routing. Order Handling Charges are the administrative charges involved in processing a new order/application for certain services – i.e. CPS, WLR or PAC etc.

In relation to the above services, ComReg had requested eircom to provide a submission for the appropriate periods from 1<sup>st</sup> December 1999 to 31<sup>st</sup> March 2004. It should be noted that these services were launched at different dates and not all of them have charges for all of the above periods. CPS was introduced into service on 1<sup>st</sup> January 2000, while WLR and the PAC charges have recently or due to be introduced.

eircom's submission's were subsequently reviewed by ComReg and ComReg directed eircom to make a number of amendments to these submissions and update the RIO with the revised charges. ComReg also directed eircom to re-calculate the amounts to be billed to operators for each of the accounting periods referred to above and to pay any monies owing to the Operators within 45 days. The revised rates for these services are set out in the attached appendices.

In relation to Order Handling Charges for Non-Geographic & Geographic Number Portability (GNP & NGNP), ComReg is currently in the process of reviewing eircom submissions for these charges and will issue a further information notice on these charges in the coming weeks.

These services are of importance to the industry and will enhance the development of competition in the market which will lead to benefits to customers. The setting of rates for these services will provide greater flexibility and commercial certainty to operators in the market.
