

## **Consultation and Draft Decision: ComReg Document 17/26**

Request for access to non-confidential models

Information Notice

## 1 Introduction

- 1. On 7 April, the Commission for Communications Regulation ('ComReg') published its consultation on the proposed pricing regime for wholesale access services in the wholesale local access ('WLA') market and in the wholesale central access ('WCA') markets, in ComReg Document No 17/26¹ (referred to in this document as 'the Consultation'). The deadline for response to the Consultation is 5pm on 19 June 2017.
- 2. The Consultation contains reference to a number of models, including the draft NGA<sup>2</sup> Cost Model, in particular in Chapter 6, which is used to derive the draft prices for Eircom's next generation fibre to the cabinet ('FTTC') wholesale access services. In addition, the Consultation also refers to the draft NGN<sup>3</sup> Core Model, in Chapter 8, which is used to derive the draft prices for current generation Bitstream services (both for Eircom and for an alternative operator).
- 3. There is also reference to a number of margin squeeze tests in the Consultation, in Chapters 10 and 11, which are assessed by various margin squeeze models including the
  - a. Retail NGA Broadband Margin Squeeze Model,
  - b. Retail CGA<sup>4</sup> Broadband Margin Squeeze Model,
  - c. Wholesale NGA Broadband Margin Squeeze Model and
  - d. Wholesale CGA Broadband Margin Squeeze Model.
- 4. The margin squeeze models referred to above ensure that there are appropriate margins between specific retail and / or wholesale products so that an alternative operator can replicate Eircom's retail and / or wholesale prices.
- 5. The various models described in paragraphs 2 to 4 above are referred to in this document as 'the Models'.
- 6. ComReg received a request from an interested party for access to the Models associated with the Consultation.
