1 Introduction

- In June 2020, the Commission for Communications Regulation ('ComReg') issued a consultation regarding the re-opening of the Third Party Business Radio licensing scheme ('Consultation 20/44')¹.
- 2 In this consultation, ComReg set out its proposals for reopening the licensing scheme, which included:
 - its preliminary view that no additional frequencies should be made available for TPBR from the VHF band, taking account of the limited demand for frequencies in that band to date;
 - its preliminary view that additional frequencies should be made available for TPBR from the UHF band, where the greatest demand for frequencies has been experienced; and
 - the application and grant process for incumbent licensees and new applicants of TPBR licences.

Respondents to Consultation 20/44

- 3 ComReg is grateful for the three responses it has received to Consultation 20/44. The interested parties who responded are:
 - Apex Radio Systems Ltd ('Apex Radio Systems')
 - RadioTrader Ltd ('RadioTrader')
 - Electricity Supply Board Networks ('ESBN')
- 4 Having carefully considered these responses, the points made therein and other relevant information, this response to consultation document sets out ComReg's assessment of, and views in relation to, the matters raised.
- 5 ComReg has published all three responses in Document 20/76s.

Structure of this document

2 Response to Consultation 20/44

Proposed Spectrum Allocation for the TPBR licensing Scheme

VHF channels

7 In Consultation 20/44, and given the limited demand for VHF channels when the scheme was last reopened, ComReg proposed not to further supplement the current number of VHF channels available for TPBR licensing².

Views of Respondents

- 8 Two respondents (ESBN and Radiotrader) were supportive of ComReg's proposals on the amount of VHF channels to be made available.
- 9 Radiotrader voiced its support for ComReg's proposal and also expressed an interest in obtaining two VHF channels.
- 10 ESBN agrees that in light of the current usage trends, it makes sense for ComReg to limit the number of VHF channels it makes available, provided that should demand exceed supply, ComReg would respond to meet any such demand.

ComReg's assessment and position

- 11 ComReg welcomes the support and interest of both respondents and notes the interest expressed by Radiotrader.
- 12 ComReg notes ESBN's suggestion, but remains satisfied that the current amount of VHF channels available will suffice.

UHF channels

13 ComReg proposed to add between 5 – 10 additional channels to the current number of UHF channels available for TPBR licensing, based on interest expressed. The final number of channels to be added would be informed by demand following this public consultation. Any unused channels remaining after the closing date of the scheme would be made available for other PMR uses.

Views of Respondents

14 Two respondents (ESBN and Radiotrader) were supportive of ComReg's proposal.

- 15 Radiotrader is supportive of ComReg's proposal and also expressed its interest in obtaining two UHF channels.
- 16 ESBN agrees with ComReg's proposal to initially make 10 additional channels available but encourages ComReg to be flexible when meeting demand, once such demand is better understood.

ComReg's assessment and position

17 ComReg welcomes and notes the views of the respondents regarding the UHF band. Given the proven demand for UHF channels in the past and based on the interest received to Consultation document 20/44, Comreg remains satisfied that a further 10 UHF channels will adequately meet demand.

Licence application and grant process

- 18 In Chapter 4 of Consultation 20/44, ComReg outlined how TPBR licences would be issued on a "first come, first served" basis as per its Guidelines Document 05/82R5. ComReg also outlined how, in order to minimise the potential for disruption to existing services, it proposes that in circumstances where it is appropriate and necessary to draw lots, successful incumbent TPBR licensees would be assigned its existing channel.
- 19 In summary ComReg proposed that:
 - it would accept applications from all interested parties for TPBR licences, for all channels that are currently licensed, one month prior to the current licence expiry;
 - it would provide interested parties with enough time, circa one month, to prepare their licence applications for the currently unassigned channels and any new additional TPBR channels;
 - it was of the preliminary view that there is no objective justification for limiting:

 (a) the number of TPBR licences which could be granted to any one applicant;
 or (b) the number of channels which could be assigned in any one TPBR licence; and
 - it would grant 5-year TPBR licences until all available channels have been assigned or until 30th November 2022, whichever is the earliest, and that, in any event, the proposed TPBR licensing scheme would close at midnight on 30th November 2022.

Views of Respondents

- 20 Two respondents (ESBN and Apex Radio Systems) were supportive of ComReg's proposals.
- 21 ESBN was strident in its support for the proposal that incumbent TPBR licensees would retain existing channels, where validly applied for, in the new licence grant process as this would avoid unnecessary cost and disruption.
- 22 ESBN outlined that it would need to provide its customers with the continuity of services being provided by its existing TBPR licenses and therefore supports ComReg's proposal that it would accept applications from all interested parties for TPBR licences, for all channels that are currently licensed and any new additional TPBR channels, one month prior to current licence expiry. ESBN further opines that having the ability to submit licence applications on-line would be welcome.
- 23 ESBN contends that ComReg should be accommodating, for example, if the case arises that ESBN renews licences and perhaps acquires additional channels in late 2020, that it would still be possible for it to obtain new 5-year licences in late 2022, thus observing the 2027 closure of the scheme, while possibly relinquishing licences acquired for the same channels in 2020.
- 24 Apex Radio Systems is pleased with the proposals, provided that it could be reissued with its existing radio channel frequencies, contending that any change would entail significant engineering time, costs and disruption to its customers.

ComReg's assessment and position

- 25 ComReg welcomes the views expressed by the respondents, ESBN and Apex Radio Systems, and it agrees that incumbent licensees should retain their existing channels where possible, thus minimising any costs or disruption.
- 26 ComReg notes ESBN's support for its proposal to accept applications from all interested parties for TPBR licences, for all channels that are currently licensed and any new additional TPBR channels, one month prior to licence expiry and intends to implement this proposal. Regarding the potential for online applications, ComReg is pleased to confirm that it intends to review application processes as part of its upcoming broader PMR review.

27 In relation to ESBN's submission regarding obtaining new licences and relinquishing old ones, ComReg notes that all TPBR licences are issued under the Wireless Telegraphy (Third Party Business Radio Licence) Regulations 2005 (S.I. No. 646/2005), for a period of five years duration and shall then expire. Regulation 6(4) of S.I. No. 646 of 2005 states "If a Licence is suspended or revoked, the Primary Licensee shall not be entitled to be repaid any part of the fee paid by the Primary Licensee under these Regulations but shall still be liable to pay any sums (including interest) outstanding", therefore if ESBN were to request ComReg to revoke a TPBR licence prior to the five year expiry date, ESBN would not be entitled to a refund of fees paid, nor could the fees be credited towards the fees for a new TPBR licence.

3 Decision

- 28 Having had regard to the above considerations and submissions from the respondents, ComReg has decided to:
 - I. retain the current number of VHF channels (see Table 1 below);
 - II. provide an additional ten UHF channels (see Table 2 below) given the demand for UHF channels;
 - III. accept applications for TPBR licences, for all channels that are currently licensed, one month prior to licence expiry;
 - IV. provide enough time, one month, for interested parties to prepare licence applications;
 - V. place no limits on (a) the number of TPBR licences which could be granted to any one applicant; or (b) the number of channels which could be assigned in any one TPBR licence; and
 - VI. grant 5-year TPBR licences until all available channels have been assigned or until 30th November 2022, whichever is the earliest, and that, in any event, the TPBR licensing scheme will close at midnight on 30th November 2022. ComReg considers that this should ensure that all TPBR licences would terminate within a clearly defined period, which would facilitate reviewing all PMR licensing schemes as part of a separate work item which will begin in Q2 2021.

5 Annex 1: Legal Framework

Wireless Telegraphy Act, 1926 as amended (the "1926 Act")

- A 1.1 Under Section 5(1) of the 1926 Act, ComReg may, subject to that Act, and on payment of the prescribed fees (if any), grant to any person a licence to keep and have possession of apparatus for wireless telegraphy in any specified place in the State.
- A 1.2 Section 5(2) provides that, such a licence shall be in such form, continue in force for such period and be subject to such conditions and restrictions (including conditions as to suspension and revocation) as may be prescribed in regard to it by regulations made by ComReg under Section 6.
- A 1.3 Section 5(3) also provides that, where it appears appropriate to ComReg, it may, in the interests of the efficient and orderly use of wireless telegraphy, limit the number of licences for any particular class or classes of apparatus for wireless telegraphy granted under Section 5.
- A 1.4 Section 6 provides that ComReg may make regulations prescribing in relation to all licences granted by it under Section 5, or any particular class or classes of such licences, all or any of the following matters:
 - the form of such licences,
 - the period during which such licences continue in force,
 - the manner in which, the terms on which, and the period or periods for which such licences may be renewed,
 - the circumstances in which or the terms under which such licences are granted,
 - the circumstances and manner in which such licences may be suspended or revoked by ComReg,
 - the terms and conditions to be observed by the holders of such licences and subject to which such licences are deemed to be granted,
 - the fees to be paid on the application, grant or renewal of such licences or classes of such licences, subject to such exceptions as ComReg may prescribe, and the time and manner at and in which such fees are to be paid, and
 - matters which such licences do not entitle or authorise the holder to do.

- A 1.5 Section 6(2) provides that Regulations made by ComReg under Section 6 may authorise and provide for the granting of a licence under Section 5 subject to special terms, conditions, and restrictions to any persons who satisfies it that they require the licences solely for the purpose of conducting experiments in wireless telegraphy.
- A 1.6 Further to section 37 of the Communications Regulation Act 2002 as amended, Regulations made by ComReg under section 6 of the Wireless Telegraphy Act 1926 as amended can only be made with the consent of the Minister for Communications, Climate Action and Environment.
