1 Introduction

- 1.1 On 3 May 2017, the Commission for Communications Regulation ("ComReg") published an updated version of the Radio Frequency Plan for Ireland ("RFPI") in ComReg Document 17/34.1
- 1.2 In ComReg Document 18/118², ComReg noted that a comprehensive update of the RFPI was anticipated following the ITU World Radiocommunication Conference in 2019 ("WRC 19").
- 1.3 This comprehensive update, as well as future updates, will be done as a <u>web application</u> which will provide additional functionality for users, such as searching and selective printing, as well as enabling ComReg to make available more regular updates of the RFPI to more accurately reflect the changing regulatory environment.
- 1.4 In the interim period between the publication of the final conference acts of WRC 19 and the launch of the online platform, it is necessary for ComReg to update parts of the current version of the RFPI in order to meet its obligations in relation to EU legislation.
- 1.5 Alongside this information notice ComReg is publishing ComReg Document 17/34R³. For the avoidance of doubt, the only substantive change between Document 17/34 and Document 17/34R is that certain tables for the frequency bands identified below have been redacted.
- 1.6 Furthermore, those redacted tables in Document 17/34R are hereby replaced with the tables set out in this Information Notice as it relates to the following radio spectrum bands:
 - 800 MHz Band;
 - 900 MHz Band:
 - 1 400 MHz Band:
 - 1 800 MHz Band;
 - 2.1 GHz Band;
 - 3.6 GHz Band; and
 - 26 GHz Band.
